4a (Code:) (Expenses \$ 290,175. including grants of \$ 300.) (Revenue \$ 157,584.) CORE CLIENT PROGRAMS: During 2016, 14 clients participated in ThinkLab and about 30 clients participated in Smart Start. Programs are for companies that own proprietary technology. In the Smart Start Program, there are further requirements that the founder must be working full-time in the business and that the TECH Fort Worth staff believe in the company's plan and believe they can help the founder to achieve the plan. The goal of ThinkLab is to develop the best business model to move the technology to market: the goal of Smart Start is to make it happen, through customized efforts to refine the plan, refer the company to appropriate management, consultants, or others, help the company find appropriate funding, etc. Smart Start clients are allowed to lease space during times when they need that space to implement

4b (Code:) (Expenses \$ 55,888. including grants of \$) (Revenue \$ 5,415.) IMPACT AWARDS: 2016 was the 8th year for this program, which recognizes "new companies with new technologies that are going to change our world." This program serves to make more entrepreneurs aware of the services we offer to help them start and grow their technology-based businesses and give many of them visibility in the business community, which we hope will result in more resources being made available to them. At the luncheon event, a keynote speaker spoke and videos of highlighted TECH Fort Worth clients were shown to the audience. The publication about the event was seen by about 50,000 subscribers of the Fort Worth Business Press. In 2016, we had about 300 luncheon attendees.

4c (Code:) (Expenses \$ 108,617. including grants of \$) (Revenue \$ 59,125.) COWTOWN ANGELS: This program was started in September 2012 to create a mechanism whereby local technology-based businesses can gain access to local funding by private investors. In 2016, 42 accredited investors paid an annual fee, which entitles them to participate in monthly meetings where the members hear pitches from local companies. TECH Fort Worth coaches the applying companies so that they present their business plan well, provides feedback to the applying companies before and after their pitches, and facilitates all of the meetings for the members of the angel network. Each member makes his or her own investing decisions.
